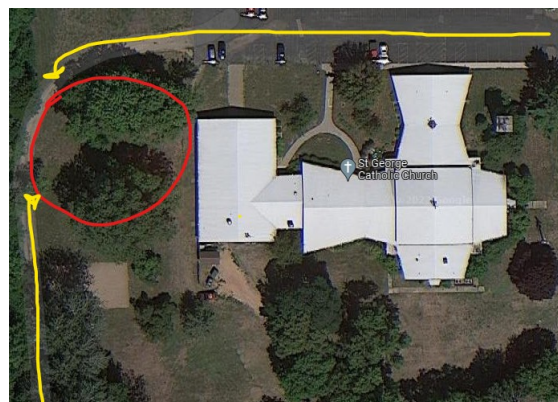

#### **Cars and Corn Regulations**

**All cars must be parked in the designated car show area and must be parked/moved by the owner(s) and cannot be moved by Corn Days volunteers. A Corn Days volunteer will be present between 9am and 11am to direct the owner where to park. For safety purposes, cars may not be removed until after the parade.**

**Owners must register his/her car, sign this hold harmless agreement, and be able to provide proof of insurance upon request. All cars are required to be insured.**

**Owners may not park the car the previous evening, will park their cars on Saturday morning, and must remove the car by 10pm when Corn Days ends.**

**The Church or its representatives are not liable for any damage sustained during the event and the owner assumes all risks.**

#### **Cars and Corn Hold Harmless Agreement**

The above-named ACTIVITY PARTICIPANT acknowledges the aforementioned rules for Cars and Corn and agrees to adhere to them. Furthermore, the above-named ACTIVITY PARTICIPANT agrees to defend, protect, indemnify and hold harmless the Church of St. George and the Corn Days Festival against and from all claims arising from the negligence or fault of the above-named ACTIVITY PARTICIPANT or any of their agents, family members, officers, volunteers, helpers, partners, organizational members or associates which arise out of the Cars and Corn Event at the Church of St. George on August 9, 2025.
